1. **INTRODUCTION:**

This prospectus is to furnish sufficient information in addition to that contained in the published advertisement, to enable prospective bidders to decide whether further investigation of the sale is warranted. Any questions concerning volume estimates and determination procedures, or anything else relevant to this sale, should be addressed to the Gogebic County Forestry and Parks Commission Office.

2. **BIDDING:**

This is a sealed bid "mill scaled" sale. Bids must be submitted on the attached bid form. The bid form contains instructions for submission and the bid deposit guarantee. The Forestry and Parks Commission reserves the right to reject any and all bids. Bids that do not meet the minimum acceptable rates will be rejected.

3. **LOCATION OF SALE AREA:**

The timber sale is located in Erwin Township, approximately 6 miles south of Bessemer on Johnson Road/McDonald Dam Road. (See Sale Location Map). The timber sale contains approximately 151 acres to be harvested. The timber sale is located in parts of Section 12, 13, & 14 T46N-R46W.

4. **DESCRIPTION OF HARVEST PRESCRIPTION:**

Selective Cut Area (149 Acres): Cut all trees marked on the trunk and stump with orange paint. Aspen, White Birch, White Spruce and Balsam Fir are designated to be cut. Sale area is bound by red, blue and yellow paint.

Clear Cut Areas (2 Acres): Cut all trees 2" dia. and larger except White Pine, Hemlock, White Cedar & Red Oak. Sale area is bound by yellow and red paint.

5. **VOLUME AND DESCRIPTION OF TIMBER:**

The Sale contains the following species and volumes:

- 5 MBF of Sugar Maple Sawlogs.
- 5 MBF of Mixed Hardwood Sawlogs.
- 1535 CDS of Mixed Hardwood Pulpwood.
- 50 CDS of Aspen Woodsrun.
- 20 CDS of Mixed Softwood Woodsrun.

6. **CONTRACT:**

The contract will contain all provisions that will be required of the successful bidder. A sample contract will be available for inspection at the Forestry and Parks Office. The contract will be issued for a period of two (2) operating seasons from the date of awarding. Normal operating season is July 1 – March 31.

7. **LOGGING AND EQUIPMENT RESTRICTIONS:**

Equipment and/or logging practices, which in the opinion of staff will cause excessive damage, will be prohibited from use on this sale.

8. **ROADS:**

There exists a network of roads to access the sale area.

9. **PAYMENTS:**


Payment for the timber removed will be based on Mill Scale. A bid deposit of 10% will be required and must accompany the bid to be applied to the purchase. Failure to exercise the contract will result in loss of the bid deposit. Purchaser must have on deposit 50% of the total bid value on or before 5/1/2017 and 100% of the total bid value on or before 9/25/2017.

10. **PERFORMANCE BOND:** A performance bond in the amount of five percent (5%) of the total bid value will be required of the successful bidder. This may be submitted in cash, surety bond or an irrevocable letter of credit acceptable to the Commission.


